

Local Law 93 of 2015 (Previously Local Law 6 of 2011) - Biannual Report

Suspensions

Pursuant to Local Law 93 of 2015, the Department of Education is required to provide reports on student discipline data (suspension data) to the City Council twice a year (October 31 and March 31). The October reporting requires citywide suspension data by month for the second half of the academic year, January through June. Per the legislation and in accordance with the Family Educational Rights and Privacy Act (FERPA), any value from zero (0) to five (5) has been redacted.

The following analyses include six month and year-over-year suspension data comparisons between SY2023-2024 and SY2022-2023.

Data from January 2024 – June 2024, when compared to the same time period in SY2022-2023 (January 2023 – June 2023), shows a decrease of 4.2% in total suspensions. Principal suspensions decreased by 5.1% and superintendent suspensions decreased by 1.2%.

When comparing the **full school years** (July 2023 to June 2024 and July 2022 to June 2023), total suspensions decreased by 2.42% with principal suspensions decreasing by 3.42% and superintendent suspensions increasing by 1.19%.

EMS Transports

In addition, pursuant to Local Law 93 of 2015, the Department of Education is required to provide the total number of EMS transports and the number of EMS transports performed because of a student's psychological/emotional condition to City Council twice a year (October 31 and March 31). The October reporting requires EMS data disaggregated by district and by month for the second half of the school year (January to June). Per the legislation and in accordance with the Family Educational Rights and Privacy Act (FERPA), any value from zero (0) to five (5) has been redacted.
