**Joshua Cabale, Special Education Teacher**



Joshua Cabale is a special education teacher at Clement C. Moore P.S. 13Q in Elmhurst, Queens. He has taught at this school for seven years and is currently teaching 5th grade students this academic year. He states, "SEGIS supports me in my daily work by providing easy access to students' Individualized Education Programs (IEPs). Access to the information allows me to check for accommodations, track individual student goals, and look at the Present Levels of Performance (PLOP) to see what strategies the student may have worked on during the previous school year."

Joshua describes the application as easy, accessible, and informative. He states, "My favorite section of the SESIS application is the student profile's *Demographics/Enrollment/Contact* section. It provides important information I can gather to know more about the student." In addition, Joshua refers to the resources available in the [SEGIS InfoHub](#) to build upon his knowledge of the application. He credits the Major Workflows in SESIS training guides for supporting him with specific processes, such as the [Annual Review](#) and [Mandated Three-Year Reevaluation](#). He adds, "I refer back to the workflows prior to the expected compliance date on the IEP so that I can be well prepared."
