



**New York City Department of Education
Report Pursuant to Local Law 12 of 2015
November 1, 2019**

Background

The New York City Department of Education monitors and addresses environmental concerns in or adjacent to NYC school buildings involving groundwater, ambient air, gas, soil, soil gas, and dust which may affect students and staff occupying NYC school buildings.

The following report, as required by Local Law 12 of 2015, contains the results of reportable environmental inspections and environmental reports that took place from July 2018 through June 2019.

Local Law 12 of 2015 specifies that this annual report shall include:

1. A summary of any reportable environmental inspections or environmental reports for the prior school year, including, but not limited to, information regarding any inspection and sampling of groundwater, ambient air, gas, soil, soil gas, and dust, unless such reporting is already required by local law.
