

Second Revised Public Notice March 22, 2016

PROPOSED NYC DOE SMART SCHOOLS BOND ACT INVESTMENT PLAN

I. Description of the subject and purpose of the proposed item under consideration.

The Smart Schools Bond Act (SSBA) authorized the issuance of \$2 billion of general obligations bonds to finance improved educational technology and infrastructure and to improve learning and opportunity for students in New York State. The New York State legislature has allocated \$783,141,339 for New York City. The SSBA requires that the New York State Education Department (SED) review and approve each school district's Smart Schools Investment Plan (SSIP) before any funds are made available for the program. Before submitting its SSIP to SED for approval, each school district is required to have a public comment process and to submit the proposed SSIP to its board of education for approval. New York City's proposed SSIP is being posted on the DOE website and public comment process, the proposed SSIP will be presented to the Panel for Educational Policy for a vote at its April 20, 2016 meeting.

Since the initial posting of the SSIP on March 4, 2016, the DOE has made the following changes:

- Additional information about particular allocations in the proposed SSIP has been added.
- The location of the March 31st public hearing has been changed to: Art and Design High School, located at 231-249 East 56th Street, New York, New York 10019.
